



## Federal Tax Credits for Energy Efficient Equipment for 2009 and 2010

### Proof of Qualified Energy Property for Claiming Tax Credits for Residential Packaged Heating & Cooling Equipment

As part of the "American Recovery and Revitalization Act of 2009", the U.S. Internal Revenue Service (IRS) is now providing consumers with a tax credits on home improvements including installation of certain high-efficiency heating and cooling equipment.
